Expected Tuition/Student Fees – NSW Smart & Skilled

The NSW Government sets the qualification prices and student fees for government-subsidised training under Smart and Skilled.

The student pays a portion of the qualification price (known as the “student fee”). The balance of the qualification price (known as the “subsidy”) is paid by the NSW Government directly to the training provider.

2023 NSW Fee-Free Initiative*

All potential students that meet the eligibility requirements for NSW Smart & Skilled Funding will have their course fully subsidised by NSW. This is a joint initiative of the Australian and New South Wales Governments, providing tuition-free training places for people wanting to train, retrain or upskill.

Fee-free* qualifications are available for people who enrol after 1 December 2022 and commence their course between 1 January 2023 and 31 December 2023. Not available for LGA40120 Certificate IV in Local Government

Fees are confirmed after a quote is given by the NSW Government.

Fees may be lower than this – based on units completed (Credits) from previous qualifications.

You are able to complete multiple qualifications in NSW at the same time. Your fees on the second qualification will be reduced to match the number of units you need to complete. Contact us for a listing of qualifications that you may be interested in completing and the associated pricing.

Glossary of Terms Used: - What do these mean

Saving On Our Fees – The amount NSW Smart and Skilled Funding covers your fee

Student Fee (NO Previous Qual) – Your remaining student fee after NSW Subsidy if you **DO NOT** have a previous Qualification

Student Fee (YES Previous Qual) – Your remaining student fee after NSW Subsidy if you **DO** have a previous Qualification

Fee-Free Scholarship – Fee exemption (only for Certificate IV qualifications) for students who are:

- aged between 15 and 30 years when you start training; and
- either the recipient of a specific Commonwealth Government benefit or allowance or the dependant of such a recipient; or
- aged 15-17 years and currently in out-of-home care or aged 18-30 years and previously have been in out-of-home care

or

- aged 15 years or over and have a letter of recommendation from a domestic and family violence service, refuge or other support agency.

Proof of eligibility is required

Disability with Documentation – Fee exemption for students with a disability(ies), proof of eligibility is required

Indigenous Students – Fee exemption for Aboriginal and Torres Strait Islander students, proof of eligibility is required
